Mr. Cross stated it was an L shaped property where they had to demo the houses that were there. Mr. Cross stated they had a conflict whenever UPS started measuring out for their lot on the other corner and found out there was some incorrect information on the plat that had already been approved, so the City engineer asked that they make the corrections. Motion was made by Luther Powell to approve setting a public hearing for February 8, 2023, to hear public comments of a replat of CWE Willis East, a subdivision of 1.2552 acres to create one commercial reserve.
